Applications received after that date will be considered on a rolling basis in grades that have openings. To submit an application, please visit the "How to Apply" page under the Admission tab on our website. You will be directed to create an online account in our enrollment portal, where you will then be able to track the status of your application file throughout the process.

The online application form includes a one-time, non-refundable \$100 application fee, which covers the cost of testing and other admission expenses. Once the application form is received, someone from our admission office will contact you to discuss the next steps in the process.

 - o Note: Requirements vary by grade. See specific grade requirements for more information.
- ✓ March 7, 2025: First round of admission decision letters sent out!
- ✓ March 21, 2025: Families notify Westminster School of their enrollment decision.
- ✓ April 30, 2025: Enrollment Contract becomes binding; first tuition payment due.
- March August: Rolling Admission season begins. Applications received during this time will be considered on a rolling basis, in grades where space permits.
- ❖ <u>Year-Round</u>: School tours, admission testing, classroom visits, and family interviews are available by appointment.

Westminster School Admission Checklist

Mid-Year Transfers

Westminster School has rolling admission; we accept students throughout the school year when we have space in a particular grade. If you are interested in applying for a mid-year transfer, please contact us directly to discuss your individual situation. See below for an outline of our general admissions process.

Admission Schedule

Applications for the 2025-26 school year will be accepted starting November 1, 2024 and should be received by February 21, 2025 to be considered in the first round of admission. Applications received after this date will be considered on a rolling basis, depending on space availability in a particular grade.

- ✓ Schedule a Tour or Attend an Open House: Interested parents should schedule a tour or attend an Open House to learn about our school curriculum, philosophy, programs, and admissions process. Dates for these events can be found online on the <u>Visit Campus</u> page of our website. Open Houses include a tour of the school, an information session with our administration, and an opportunity for conversation with a panel of current staff, students, parents, and board members. See the school and have your questions answered!
- ✓ **Apply Online:** The link to our online application can be found on the **How to Apply** page of our website. You will need to create an account with your email address where you will receive a link and a code to begin the application process. You will have access to the Enrollment Portal to check the status of your application file at any time. *The application includes a one-time, non-refundable \$100 application fee.*
- ✓ **Submit Supporting Documents:** Once the initial application form has been submitted, we ask that you provide us with the following documents to accompany the application file and help us get to know your child.
 - ✓ Academic records/transcript -- Download the <u>Transcript Release Form</u> in the portal.
 - ✓ **Teacher recommendations** -- We request 1-3 teacher recommendations, depending on grade level. All recommendation requests can be accessed through the online portal system. Parents will enter the teacher's email address and the recommendation requests will be sent directly to the teacher who will complete the form and return it to us.

- ✓ **Admission Testing:** Testing of prospective kindergarten 2nd grade students takes place on campus, by appointment with the admissions office. For students applying to grades 3-7, we ask that you submit a student's recent SSAT or ISEE test scores. Westminster School will provide test registration information and occasional testing accommodations throughout the admission season. Check with our Office of Admission for specific test dates and requirements. *Note: Westminster School does not consider applicants for 8th grade.*
- ✓ **Student Shadow Day:** Prospective students will be paired with a Westminster student in their same grade and are invited to attend a full day of school here with us. The shadow day gives candidates an opportunity to interact with their teachers and peers and experience a day in the life of a Westminster student. Candidates are encouraged to actively participate in class and take part in school activities throughout their visit. Teachers will provide feedback, which will be shared with parents in the final stages of the admission process. *Note: Kindergarten applicants are invited to tour the school but do not have a Shadow Day.*
- ✓ Parent Interview: The parent interview allows our admissions team to get to know you as a family and affords parents the opportunity to ask questions about a particular grade, program, or feature of the school. At this time, we will provide a thorough and up-to-date overview of your child's application file and admissions status.
- ✓ **Notification:** Once all steps have been completed and application documents submitted, we thoughtfully review the applicant's file to determine whether your child will be a good fit for Westminster School and would benefit from our programs. Admission decisions are made within two weeks of receiving a candidate's <u>completed</u> application file.
- ✓ Enrollment: With your admission notification, accepted candidates will be issued an Enrollment Contract and several registration forms through the Enrollment Portal. Once we inform you of our admission decision, we ask that you respond to our offer within two weeks, to save your child's spot in a particular grade. After the two-week period, your child's spot cannot not be guaranteed. Once the Enrollment Contract with a \$1,500 non-refundable deposit has been received, your child will be officially enrolled! Note: The deposit amount will be applied to your first tuition payment.



Answers to Frequent Questions

Why should I send my child to your school? Westminster offers a superior elementary education based on high curriculum and achievement standards. The rich curriculum, focused academics, and traditional environment of respect, courtesy, responsibility, and warmth provide a significant alternative to the public school system. Kindergarten-2nd grade students get a strong start with a phonics-based reading program, a math program that stresses reasoning and a solid grounding in math facts, hands-on science, an introduction to history and geography, French, music, art, PE, library, and Junior Great Books. The core curriculum for grades 3-8 is enhanced by the addition of STEAM classes, as well as Classical Studies, which trace the history, culture, art, and literature of Western Civilization. Upper school students add Latin, Algebra, and Geometry. An outstanding feature of Westminster is its Drama Program in which all students participate each year. The repeated experience of preparation and public performance helps students develop self-confidence, poise, and self-expression.

Why do students like your school? Students enjoy the after-school Athletic Program; the many field trips and special assemblies; the aesthetic environment; the celebrations of curriculum, such as Egyptian Day, Science Week, and Sports Day; the drama presentations; the talent shows; the many clubs, enrichment programs and camps that are offered; and, most of all, the sense of close community and caring possible in a small school.

Do you offer extended care? Both morning and afternoon extended care are available. The regular school day is from 8:05 a.m. - 3:10 p.m. (Regular drop-off begins at 7:45 a.m.) Extended care begins at 7:00 a.m. and ends at 6:00 p.m. (with a grace period until 6:15 p.m. for late pickup). Children may enroll in the full-time extended care or may use the drop-in service on an as-needed basis.

Do you provide transportation? Door-to-door bus service is available to many Fairfax County neighborhoods. Many of the remaining families participate in carpools whose organization is facilitated by the school.

Are there special requirements for admission to your school? Admission to kindergarten is based on birth date, order of application, and developmental readiness testing. For grades 1-7, admission is based on order of application, the results of a qualifying exam, a writing sample, teacher evaluation, and an interview with parents and child. Westminster School does not admit new students to the 8th grade.

Are you full? How much is tuition? Most grades usually have some openings for new applicants. The number of openings varies from year-to-year and grade-to-grade. Registration is limited to 18 students (16 in kindergarten) per class, and two classes per grade. Annual tuition ranges from \$29,900 - \$35,146. Various payment plans are offered with discounts

awarded for paying in fewer installments. Financial aid is available; awards are based on need. More information about financial aid is available on the admissions page of our web site.

How long has your school been established? Westminster School was established in 1962. It is a fully accredited member of the Virginia Association of Independent Schools (VAIS), the National Association of Independent Schools (NAIS) and is a member of the Association of Independent Schools of Greater Washington (AISGW).

What is the background of the Head of School? After 30 years of service to Westminster School, Nancy Schuler was named Head of School in 2021. She is the third Head of School since Westminster's founding in 1962. Prior to becoming Head of School, Mrs. Schuler served as a history teacher, team leader, department chair, summercamp director, and admissions director. Mrs. Schuler holds a BS in Elementary Education with a concentration in Business Administration and a MEd in Independent School Leadership.

Are you planning any changes? Westminster's longrange plans include the addition of a regulation size athletic field and a new wing for the Upper School.

APPLICATION AND TESTING

Applies to new students only, including siblings. Fee covers application processing and testing for entry to K-7 -\$100 non-refundable. For new students to Westminster's preschool, including siblings, the fee is \$50 non-refundable. Westminster's preschool students applying for kindergarten will be considered returning students and not charged the application fee, however, the registration fee still applies.

REGISTRATION

ENROLLMENT

FINANCIAL AID

Also required: Submit a copy of your prior year's IRS 1040 tax return directly to Business Manager, Westminster School. Note: Deadline to submit SSS forms is February 23, 2024, and 2023 tax returns by April 18, 2024 in order to have any award applied properly to the first tuition payment in FACTS. Westminster's preschool students are only eligible for financial aid if they attend full time and have a sibling in K-8.

EXTENDED CARE PROGRAM SUMMARY

The Extended Care Program Agreements on page 3 must be signed by both parents/guardians and returned in hard copy (for all grades, including preschool).

Westminster School offers a comprehensive Extended Care Program to families with children in all grades, *Preschool-8. The program is divided into two full-time components—Early Care (before school) and After-School Care (Preschool-8) - with Drop-In options for each. General program descriptions, policies, fees, and enrollment agreements are given below.

EARLY CARE

Hours of Operation: 7:00 - 7:45 a.m., Monday - Friday, on every school day (including half days).

- > There is no Early Care or when school is canceled due to inclement weather or emergency response.
- ➤ In general, in case of delayed school opening, Early Care will open according to the following schedule: 2 hour delay 9:00 a.m. Occasionally, it may be advisable to cancel Early Care due to severe weather conditions. Such decisions will be included in school announcements.

<u>Program Description</u>: Early Care (a state-licensed extended-day program) provides safe and enjoyable morning care prior to regular school hours. Supervised activities and free play take place in designated classroom(s). Fees and other requirements are shown below.

DROP-IN EARLY CARE

Early Care is also available daily on a drop-in basis. Fees and other requirements are shown below.

AFTER-SCHOOL CARE

Hours of Operation: For grades K-8: 3:15 - 6:00 p.m. For preschool: 3:00 - 6:00 p.m. Monday - Friday, on every full day of school. (Children must be picked up by 6:00 PM. A late fee will be assessed beginning at 6:01 p.m. and will increase incrementally as listed below*) There is no After-School Care on half-days, holidays, when school is canceled or dismissed early due to inclement weather or emergency response, or when all after-school activities are cancelled due to inclement weather or emergency response. Occasionally, it may be advisable to close Westminster School, including After-School Care, by 4:30 p.m., due to late-developing inclement weather or emergency response. Such decisions will be included in school announcements.

Program Description: After-School Care (a state-licensed extended day program) is a safe, enjoyable program of on-site, after-school care which provides a fun, wholesome break from the school-day routine while also supporting the structure of the Westminster program. After-School Care activities may take place in classrooms, playground, gym, and theater. The daily schedule includes homework/quiet time, wholesome snack and drink, and a variety of activities, including outdoor play, arts and crafts, board games, library/story time, etc. Fees and other requirements are shown below.

To Students and Families Applying to Washington-Area Independent Schools for Admission in 2025-2026

To promote a fair and transparent admission process, the member schools of the Association of Independent Schools of Greater Washington ("AISGW") have established the following guidelines for working with families and students applying to their schools. All AISGW schools and applicant families are expected to abide by these guidelines.

Schools should make clear to applicants all dates pertaining to admission and re-enrollment. AISGW recommends the following timeline:

- Notification Date Notification of admission decisions shall be the first Friday in March (March 7, 2025). Electronic notification, which includes email, telephone, on-line portal or any other form of instant notification, shall not occur before 4 pm. Letters may be placed in the U.S. mail any time on the first Friday in March.
- Registration/Reply Date Enrollment contracts for newly admitted students are due back to the school no earlier than the third Friday in March (March 21, 2025), or two weeks from the date of notification.
- Tuition Binding Date Enrollment contracts for newly admitted and re-enrolling students are binding as of 4:00 pm on June 1. This means that schools may not release the tuition obligation of a family that has already enrolled unless the family notifies the school of its decision to enroll elsewhere by 4:00 pm on June 1. If June 1 falls on a weekend, the binding date shall be 4:00 pm on the immediately preceding Friday.

Upon receipt of an application, member schools of AISGW presume that if an applicant is currently enrolled at another independent school, the applicant's family already has notified that school of an intention to apply elsewhere in the independent school community.

An AISGW member school will not accept a student from another AISGW school without receipt of appropriate records directly from the student's present school. Families are required to request the relevant records (i.e., transcripts) from their current school as part of the application process.

Families should inform all independent schools to which they have applied if and when they no longer seek admission to the schools for the coming academic year.

Families should not submit an enrollment deposit at more than one school.

With respect to financial aid, families should note the following:
